WHOSE BUSINESS IS THE ARTS?

Throughout 2016, the Arts Council has been gathering data for the Americans for the Arts national economic impact study, "Arts & Economic Prosperity V." Once every five years, the Arts Council participates in this research by collecting information from cultural non-profits and their audiences in the counties of Carbon, Lehigh, and Northampton. Thanks to your participation, we were able to provide nearly 100 organizational surveys and 800 audience surveys from the Lehigh Valley.

Americans for the Arts will analyze the data over the next several months and provide our region with its own detailed report in June 2017. At that time, the Lehigh Valley Arts Council and the Lehigh Valley Partnership will cohost the Whose Business is the Arts? public forum to release the results to the community and address challenges of mutual concern.
